

**MINUTES of a regular public meeting of the Board  
of Park Commissioners of the Batavia Park District,  
Kane County, Illinois held at 327 West Wilson  
Street, Batavia, Illinois at 7:00 p.m. on the 19th  
day of January, 2010.**

The President called the meeting to order and directed the Secretary to call the roll.

Upon the roll being called, the following Park Commissioners answered present:  
Corken, Foiles, Tilmon. The following Park Commissioners were absent from the  
meeting: Behmer and Callahan

The President announced that the next item of business before the Board of Park  
Commissioners was the consideration of an ordinance abating the tax heretofore levied for the  
year 2009 to pay debt service on the \$3,700,000 General Obligation Refunding Park Bonds  
(Alternate Revenue Source), Series 2003, of the Batavia Park District, Kane County, Illinois.  
Following a full and complete discussion thereof, President Callahan presented and the Secretary  
read in full (*waived*) an ordinance as follows:

## ORDINANCE #287

***AN ORDINANCE* abating the tax heretofore levied for the year  
2009 (payable in 2010 to pay debt service on \$3,700,000  
General Obligation Refunding Park Bonds (Alternate Revenue  
Source), Series 2003 of the Batavia Park District, Kane County, Illinois.**

**WHEREAS**, the Board of Commissioners (the "Board") of the Batavia Park District, Kane County, Illinois (the "District") by ordinance adopted on October 21<sup>st</sup>, 2003, (the "Ordinance"), did provide for the issue of \$3,700,000 General Obligation Refunding Park Bonds (Alternate Revenue Source) Series 2003 (the "Bonds"), and the levy of a direct annual tax sufficient to pay principal and interest on the Bonds; and

**WHEREAS**, the District will have Pledged Revenues (as defined in the Ordinance) available for the purpose of paying debt service on the Bonds heretofore imposed by the 2009 levy; and

**WHEREAS**, it is necessary and in the best interests of the District that the tax heretofore levied for the year 2009 to pay such debt service on the Bonds be abated:

**NOW, THEREFORE**, Be It and It is Hereby Ordained by the Board of Park Commissioners of the Batavia Park District, Kane County, Illinois, as follows:

**Section 1. Abatement of Tax.** The tax heretofore levied for the year 2009 (and payable in 2010), in the Ordinance is hereby abated it its entirely.

**Section 2. Filing of Ordinance.** Forthwith upon the adoption of this ordinance, the Secretary of the Board shall file a certified copy hereto with the County Clerk of Kane County, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2009 in accordance with the provisions hereof.

**Section 3. Effective Date.** This ordinance shall be in full force and effect forthwith upon its adoption.


