

ORDINANCE #299

***AN ORDINANCE* abating the tax heretofore levied for the year
2010 (payable in 2011 to pay debt service on \$3,700,000
General Obligation Refunding Park Bonds (Alternate Revenue
Source), Series 2003 of the Batavia Park District, Kane County, Illinois.**

WHEREAS, the Board of Commissioners (the "Board") of the Batavia Park District, Kane County, Illinois (the "District") by ordinance adopted on October 21st, 2003, (the "Ordinance"), did provide for the issue of \$3,700,000 General Obligation Refunding Park Bonds (Alternate Revenue Source) Series 2003 (the "Bonds"), and the levy of a direct annual tax sufficient to pay principal and interest on the Bonds; and

WHEREAS, the District will have Pledged Revenues (as defined in the Ordinance) available for the purpose of paying debt service on the Bonds heretofore imposed by the 2010 levy; and

WHEREAS, it is necessary and in the best interests of the District that the tax heretofore levied for the year 2010 to pay such debt service on the Bonds be abated:

NOW, THEREFORE, Be It and It is Hereby Ordained by the Board of Park Commissioners of the Batavia Park District, Kane County, Illinois, as follows:

Section 1. *Abatement of Tax.* The tax heretofore levied for the year 2010 (and payable in 2011), in the Ordinance is hereby abated it its entirely.

Section 2. *Filing of Ordinance.* Forthwith upon the adoption of this ordinance, the Secretary of the Board shall file a certified copy hereto with the County Clerk of Kane County, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2010 in accordance with the provisions hereof.

Section 3. *Effective Date.* This ordinance shall be in full force and effect forthwith upon its adoption.

Commissioner Corken moved and Commissioner Foiles seconded the motion that said ordinance as presented and read by the Secretary be adopted.


After a full discussion thereof, the Treasurer directed that the roll be called for a vote upon the motion to adopt said ordinance as read.
